



**ATHLETIC DEPARTMENT: Part-time Head Women's Wrestling Coach – sponsored by FSA**

Provides leadership and coaching to members and staff of the Nassau Community College Wrestling Program. The team competes on the NJCAA Division III level. Ensures that student-athletes meet all NJCAA and College academic requirements. Duties and responsibilities include but are not limited to: direction and oversight of the program; coaching, recruiting, team travel, practice, match day preparation, and management of staff; assists with non-conference scheduling. Provides effective management of matches, practices and supervision of staff; establishes a strong working relationship with the College and surrounding community by recruiting local talent, promoting attendance at matches and community functions; develop and curate meaningful relationships with Long Island high schools and wrestling community, NYC Beat the Streets and other reputable wrestling associations. Follows NJCAA, Region 15, and College rules and regulations; foster a culture of accountability and develops student-athletes academically, physically, mentally and emotionally for competition and life skills; optimizes and manages camps and clinics. Assists and supports the enrollment, academic persistence, retention and graduation for student-athletes; demonstrates effectiveness in monitoring student-athletes academic progress, retention, graduation, and eligibility status; promotes academic progress of student athletes by working closely with Compliance and Academic Student Services; assists in enforcing academic support services/activities; i.e. study hall, tutoring, academic advising, life skills, etc. Supports the sports medicine staff to ensure student athlete welfare. Promotes and champions equity, diversity and inclusion and actively engages, educates and empowers student-athletes in DEI initiatives and trainings. Performs other special assignments as assigned by the Director of Athletics.

Bachelor's degree required; master's degree preferred. A high degree of professional and personal integrity and respect for the values of the College is essential. Collegiate wrestling coaching experience preferred. Strong organizational and effective communication skills and a thorough knowledge and understanding of NJCAA rules and regulations are required. Proven ability to lead and manage people with demonstrated success in teaching the skills and fundamentals of the sport; ability to organize and motivate student-athletes to a maximum performance level in sports fitness and academic achievement required. Recognized in the wrestling community as a reliable and knowledgeable leader and team builder possessing a strong work ethic with high integrity. Proven experience in recruiting highly motivated/qualified student-athletes and maintaining compliance with all NJCAA, Region 15, and College rules and policies essential. Demonstrated advocacy for promoting an equitable, diverse and inclusive culture and learning environment for student-athletes.
