ENTRY: The entry fee is \$25 for one style and \$40 for both, which must be paid together at the time of registration. If a wrestler signs up for both styles but fails to compete in the first, he/she will be required to pay the additional fee and weigh-in again before being allowed to compete in the second style.

ELIGIBILITY: This event is open to all NY resident wrestlers that meet the age requirements for Age Groups in the tournament. All wrestlers must have a current USA Wrestling membership card to participate. Cards are obtained on-line at themat.com. Please contact your Sectional Representative if you need directions on how to obtain a card.

WEIGH-INS: All weigh-ins shall take place at the event venue. **THERE WILL BE NO FAX WEIGH-INS.** Please see Schedule for Registration and Weigh-in times. Athletes competing in both styles may weigh in once for both styles. This is contingent on the athlete actively competing in the first style scheduled to be wrestled. Should the athlete not compete in the first style after weighing in, he/she shall be required to weigh in again for the second style, with no weight allowance.

RULES: The current rules of FILA with USA Wrestling modifications will govern this event.

UNIFORMS: Red and Blue singlets or red/blue reversible singlet with under briefs **ARE REQUIRED.** Headgear will be **MANDATORY** for all competitors.

AWARDS: Top four (4) in each weight class will receive awards.

PAIRINGS: Random draw vertical pairing will be used for this event. Wrestlers from the same section will be separated and also from the same club if possible. Two (2) pools will be used in weights with six (6) or more entrants, with pool place winners wrestling place winners from the other pool for final placement. Weights with only two (2) wrestlers shall wrestle best two (2) of three (3).

MEDICAL INFORMATION: All athletes must be present in a competition singlet and submit to a skin check prior to weighing in. The Head Trainer has full authority in determining the eligibility of an athlete to compete.

DIRECTIONS TO THE VENUE

FROM NORTH – NYS Thruway (I-87) SOUTH to Exit 13S (Palisades Parkway South). Go 0.8 mile to Exit 8W & take ramp RIGHT for Rte 59 WEST toward Spring Valley. Go ¼ mile then take ramp RIGHT and follow signs for Rte 304 North / S. Main St. Go 1.3 miles and turn RIGHT on Bardonia Rd. Travel ¾ mile and turn RIGHT onto Germonds Rd. Go 0.4 mile and turn RIGHT onto Demarest Mill Rd.

FROM NYC / LONG ISLAND – take NYS THRUWAY (I-87) NORTH over TAPPAN ZEE BRIDGE TO Exit 12. At end of ramp go LEFT on North Palisades Center Drive for 0.1 mile and then turn RIGHT onto Snake Hill Rd and go approximately ¾ mile to Old Mill Rd. Go LEFT on Old Mill Rd. After 0.4 mile, road changes name to Germonds Rd. Go 0.1 mile and turn LEFT onto Demarest Mill Rd.

The undersigned expressly and voluntarily assumes all risk of personal injury, permanent, temporary, total or partial disability, disfigurement, paralysis and any other losses or damages to person or property, or death, sustained while participating in, attending, preparing for, or traveling to and from the "Event", including passive or active negligence of the tournament officials, and USA Wrestling or hidden, latent or obvious defects in the facility or equipment used.

Release, waive, discharge and covenant not to sue USA Wrestling, its affiliated clubs, their respective administrators, directors, agents, coaches, and others of the organization, other participants, sponsoring agencies, sponsors, advertisers, the owners and leasers of the premises used to conduct the "Event", all of which are hereinafter referred to as "releasees", from any and all liability to the undersigned, his or her heirs and next of kin, for any and all claims, demands, losses or damages on account of injury, including death, or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise.
