**USA Wrestling Cards required. (Checks MUST be made out to: Nassau NYS-USA Wrestling)**  
Must show USA Wrestling card at the weigh-ins. Cards may be obtained on-line at [themat.com](http://themat.com). You may sign-up on site for a card at weigh-in for \$35.00. You **MUST** bring a copy of your birth certificate (non-returnable) in order to purchase card.

**UNIFORM:** Red and Blue singlets or a Red/Blue reversible singlet with briefs, wrestling shoes (no hard sole sneakers permitted). Protective headgear is not required, but is recommended.

**RULES:** International rules of FILA with USA modifications. Rules clinic will precede wrestling. Vertical Pairing or Round Robin Bracketing to be used. Separation by Club or Town.

**BOUTS:** All Weight Classes (3) 2-minute periods w/30 second rest between periods.

**AWARDS:** 1<sup>st</sup> - 3<sup>rd</sup> Place medals

**SCHEDULE:** ALL WEIGH-INS WILL TAKE PLACE ON THE DAY OF THE TOURNAMENT – NO ADVANCE WEIGH-INS
