Eligibility: Any wrestler meeting age requirements

Uniform: Red and Blue singlet or Red/Blue reversible with underbriefs mandatory

Awards: Medals to first 3 places in each weight class (participation medals to all intermediate and novice wrestlers)

Bouts: All weight classes: three 2-minute periods with 30-second rest between periods.

Rules: International rules of FILA with USA modifications. Rules clinic will precede wrestling. Vertical pairing or round robin bracketing to be used. Separation by club or town.

All wrestlers in the Kid division (born 95-00) qualify for the New York State Kid Freestyle/Greco Championships. All wrestlers in the Cadet division (born 93-94) qualify for the New York State Cadet Freestyle/Greco Championships. Qualifying for all schoolboy, cadet national teams, and the Northeast Kid/Cadet Regionals will take place at the State Tournaments.

*** Cadet National Team qualifiers will need a **\$400** deposit at the State Championship. ***

Releasor understands and acknowledges that USA Wrestling activities and the sport of wrestling in general have inherent dangers that no amount of care, caution, training, instruction, supervision or expertise can eliminate. RELEASOR EXPRESSLY AND VOLUNTARILY ASSUMES ALL RISK OF PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, sustained while participating in, attending, preparing for or traveling to and from any USA Wrestling s sanctioned event, meet, practice or activity, including the risk of PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES, or hidden, latent or obvious defects in the facilities or equipment used.

Releasor acknowledges and fully understands that each participant in any USA Wrestling sanctioned event, meet, practice or activity, including Releasor, will be engaging in activities that involve risk of serious injury, including permanent, temporary, total or partial disability, disfigurement, paralysis and any other losses to person or property, including death, and that severe social and economic losses may result not only from Releasor's own actions, inactions or negligence, but also from the actions, inactions or negligence of others notwithstanding the rules of play or the condition of the premises or of any equipment used. Further Releasor acknowledges and fully understands that there may be other associated risks with such activities which are not known or not reasonably foreseeable at this time.

I ACKNOWLEDGE THAT I HAVE HAD SUFFICIENT OPPORTUNITY TO REVIEW THE PROVISIONS OF THIS DOCUMENT AND UNDERSTAND ITS PURPOSE, MEANING AND INTENT.
