## GOALS

The purpose of this event is to provide novice wrestlers with a more competitive tournament experience.

## CONCEPT

1. Entry fee will be **\$10.00** for each wrestler entered up to a maximum of **\$150.00** per team.

4. Entries are unlimited in each weight class.
5. **NO SENIOR (twelfth grade) wrestlers may be entered.**
6. **Any wrestler who participates in this Novice Tournament is *INELIGIBLE* to participate in this year's Qualifying Tournament or Sectional (County) Tournament.**
7. Honor weigh-ins will be conducted on the morning of Friday, January 30, 2009.
8. Place an asterisk (\*) in front of the name of any above average junior varsity wrestler.
9. Fax the NCWCA Novice Tournament Honor Weigh-in Sheet *signed by your Athletic Director* to Dan Krauz at Great Neck North HS [516-773-8391] **NOT LATER THAN 12:00 NOON** on Friday, January 30, 2009.
10. The Tournament Directors will bracket the entrants.
11. Scratch Meeting: Saturday, January 31, 2009 at 9:00 AM
12. Wrestling Begins: Saturday, January 31, 2009 at 9:30 AM
13. **Awards will be presented to four places in each bracket.**
14. Weight classes may be split into multiple brackets if sufficiently high enrollment warrants doing so.
15. Each participating school is required to supply personnel to assist with timing and scoring.
